

I also believe from what lost and missed by not times over the past three ensuring ALL members years is that our existing cannot imagine this world


all took in those we degrees.

Connecticut is among 30 states allowing the sale of raw milk, but the debate over the health benefits and the risks - rages on.

Rick Plumb, who owns Meadow Ridge Farm in Litchfield, where more than 99 percent of the milk is sold at wholesale and less than 1 percent is sold as raw milk, says he is not

on either extreme. "Anymilkthatacustomer can buy in the store is fine," he said Wednesday morning. "Maybe through the pasteurization and homogenization process the milk is altered, but it's still a good, wholesome product. It's just kind of a personal preference to want to buy raw milk."

Cottage Cheese Pie

- 2 Cups Cottage Cheese (small curd)
- 1 scant Cup of sour milk (add 1 tbsp. vinegar to sour it)
- 2 Eggs
- 1/2 Cup Sugar
- 1/2 teaspoon Salt
- 1 regular pie crust

Preheat oven to 400°. Line pie pan with crust. Place all ingredients in mixer or blender. Mix thoroughly. Pour into pie pan lined with crust. Place pie on foil-lined cookie sheet and put into oven. Bake one hour, or until toothpick comes out clean. Cool before serving and store in refrigerator.





First he discussed what the queens do: lay eggs. Their life span is about 5 years. The worker bees are also female. They start out in the hive when they are born guarding the hive, building combs or making wax. They don't go out of the hive till later. Worker bees don't last too long; they can last 5 days to a few weeks depending how long their wings last. Once they wear out their wings, they die. This why the queen is so active producing eggs; because she has to be able to replace all those worker bees. Bees are active all the time and never sleep. The drones, the males, don't do too much except hang around waiting to mate with a virgin queen bee. There was much more he showed demonstrated about the hive: the type of combs used and parts of the hive. So it was a good overview on what bees are and the art of keeping bees.







Farm Bill is a step forward The US Department of were especially critical



We finally got a Farm Bill passed that was signed into law by the President in February. This has been a three year project and while not perfect, it at least continues some of the farm programs.

The bill does include some favorable provisions such as the dairy insurance program that will benefit the smaller dairy farms in Connecticut. The bill also enacts several new provisions for environmental and conservation programs. Some of the programs included in the Farm Bill are the Healthy Food Financing Initiative, National Organic Program, Specialty Crop Block Grants and SNAP. They expanded the use of SNAP benefits to include use at Farmers Markets. The law did terminate the direct crop payment program which according to what I am told, will save \$5 billion a year. In its place they will implement a crop insurance program.

Agriculture will now have to digest the 1000 page plus bill and work out details of the bill. I understand that they have temporally continued the milk subsidy program until the details of the new programs are set.

One of the interesting occurrences with the Farm Bill is that none of Connecticut's Congressmen or Senators voted in favor of the bill. We reached out and asked why the Connecticut delegation did not support the Farm Bill in the end. Earlier we had been told by different congressional and senatorial offices that most would be supporting the Farm Bill. The response that we got was that they recognized that bill contained several favorable provisions and represented a significant step forward agricultural for the The Senators economy. Representatives and felt that they could not support the bill because of cuts to the Supplemental Nutrition Assistance Program (SNAP) that had been included in the Bill. They responded that they felt that the cuts would be very detrimental to many of their constituents. The cuts would disproportionally impact our state's They struggling families.

of the increase in the "Heat and Eat" threshold. Connecticut, along with other states, allows families who are receiving, sometimes minimal, energy assistance to be eligible for SNAP benefits, which increases the overall benefits for needy families. The bill increased this threshold which SNAP assistance can be provided and this would negatively impact SNAP participation in our area.

Now that we are reaching better weather and Granges are reawakening after our winter we should start looking at resolutions we can present to our Granges. If you have any thoughts on a particular topic that you would like the Grange to pursue, write a resolution. Once it is presented to your local community Granges. The resolutions should also be presented to your Pomona Granges for action before submitting them to the State Grange. Not all resolutions need to be a state or national issue. Resolutions could be on a topic concerning your local community on which your Grange would like to make a statement. These would not have to be passed on up the line to State Grange.

We are hoping our four officers that have had medical problems are on the mend and will be at our June meeting which will be elections of officers.



Raw milk

However, Plumb acknowledges the reason why pasteurization began over 100 years ago: Raw milk was making people sick.

In 1864, Louis Pasteur, a French chemist and microbiologist, discovered the process of heating milk to a temperature high enough to kill pathogens that could make people sick. Then to quickly cool it.

Proponents of raw milk argue that good bacteria, vitamins and enzymes are lost in the process, while health officials say pasteurized milk has comparable health benefits without the risk of illness posed by raw milk.

The Food and Drug Administration only supports consumption of Grade A, pasteurized milk, and the Centers for Disease Control warns of health risks on its website.

Of raw milk, Steve Jensen, a spokesman for the Connecticut Department of Agriculture, said, "We do have a more stringent inspection program, because of the nature of it, but we have no official stance on its consumption."

Among some of Connecticut's requirements, raw milk must be cooled to 40 degrees Fahrenheit or colder within three hours of completion of milking; tanks and bulk storage containers must be cleaned and sanitized every 48 hours and herds must be tested annually for brucellosis and tuberculosis.

Another requirement deals with the labeling.

Plumb took a gallon of raw milk out of a refrigerator and showed a portion of the label that says: "Raw milk is not pasteurized. Pasteurization destroys organisms that may be harmful to humans."

Some raw milk advocates are pushing for less government regulation, but Plumb said, "They should make it hard because it's a raw product. It's not sterilized and the state would prefer not to have it."

Though he added, "Milk is handled better now. Raw milk is a much safer product than when pasteurization came into play, but it has to be monitored very closely."

Anita Schubert started the Manchester/Glastonbury chapter of the Weston A. Price Foundation with Sharon Ahern last fall.

The foundation heads up the Real Milk Campaign started by Shelly Fallon in 1999. It provides health information on raw milk, lists providers, advocates for legislation that would legalize raw milk in every state, and says it supports consumers' freedom of choice to buy raw milk.

Schubert, who lives in Manchester, started drinking raw milk two years ago.

"I learned about what pasteurization does to the milk," she said. "It takes away a lot of natural nutrients."

She says pasteurization kills good bacteria your body needs and removes fat containing vitamins A, D and K2, while only restoring a synthetic form of vitamin D.

Some proponents of raw milk claim drinking it prevents asthma, heart disease, allergies and cancer. But the CDC disputes such claims.

In fact, there is strong opposition to the human consumption of raw milk.

On Dec. 16, 2013, the American Academy of Pediatrics came out with a policy statement recommending that pregnant women, children and infants not drink raw milk due to the risk of listeria, salmonella and other other pathogens. It also said purported health benefits of consuming raw milk products "have not been clearly demonstrated in evidence-

There were no answers to the April Window Picture.

based studies, and therefore do not outweigh the risks of raw milk consumption."

A study published in the CDC Journal of Emerging Infectious Diseases found 60 percent of 121 dairy-related disease outbreaks from 1993 to 2006 were caused by raw milk products, according to the CDC website.

The Weston A. Price Foundation disagrees with the AAP's statement and Schubert contends organizations like AAP, the FDA and the CDC have an agenda to support the commercial milk industry.


"Children raised on raw milk over pasteurized milk have way better health," she said. "I think those organizations are ignoring and distorting."

Schubert, who buys her milk from CCC Farm Store in Manchester, marvels at how fast the bottles disappear from its shelves.

By Monday, regulars come in asking when the next delivery will be, according to Lucy Longoria, the store manager.

"We call them 'milkier'," she said with a chuckle. "The demand for raw milk, it is absolutely amazing. We have three or four new people a day."


